
Please bring a copy of your approved Solicitation Permit Application and your paid receipt to the Police Department to pick up your permit and the identification tags.

Per Chapter 16 of the Village Code, listed below are some key points to keep in mind while soliciting in the Village (please refer to Chapter 16 for a complete summary of all guidelines and restrictions):

- Any person engaged in the act of solicitation shall be sixteen (16) years of age or more AND shall be wearing a **high visibility vest**
- It shall be unlawful for any person to engage in solicitation at any time prior to **9:00am or after 7:00pm**
- No solicitor shall interfere with either vehicular or pedestrian traffic on the public right of way
- Each permittee shall wear an identification badge on outer garments to be visible at all times (issued by the Police Department)
